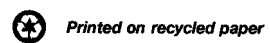

To qualify for a NH-DI college scholarship the applicant must 1) Be a graduating High School senior attending an accredited College in the fall. 2) Have been a participant in New Hampshire Destination Imagination for one or more years. 3) Fill out an application listing their involvement in NH-DI and any NH-DI awards received. 4) Provide a letter of recommendation from their adult team manager. 5) Provide a letter of recommendation from a school official. 6) High School transcript for the past two years and class rank. 7) An official copy of their SAT/ACT scores. 8) Write an essay, story or poem, limited to two pages in length, that conveys a picture of the applicant. Up to two scholarships are awarded based on the decision of the scholarship committee. The committee is formed of four or more members and include NH-DI board members and select non-board members who are heavily involved in the program and are familiar with the applicants, their teams, their performances, and their spirit. Committee members must not be related to any of the applicants.
